

**Kinetic Civic Education** 

This organization is a proven critical thinking program that allows users of the guide to interact with Queens and orient themselves depending on their circumstances as an American Citizen, American Long-Term Resident, and American Visitor. We advocate, so others learn, and therefore the community prospers.

Developed by a Yale University and Bronx High School of Science Alumna Kimberly Cruz, you will receive updated support from an intersectional perspective with a five-part Knowledge Tree™. We build on your individualized booklet which you will receive on your first day, and the orientation packet generic version is free online for you to see what you may encounter in the KCE Queens Orientation Program.



The Pyramid of Life

The basics will be covered such as understanding the foundational American principles that have shaped our history around communication, compatibility, accountability, and family structure. We will also discuss the core services which are City Services, Health, Insurance, Technology, and Education. Third, we will cover the branches which will cover the six ways people interact in civil society through death, military, family life, rest, workplace, or schooling. The leaves will allow civilians to be able to see the impact when humans are not in a vacuum and we need to focus on the quality of our food, sanitation, water, air, and energy crisis when critically thinking about the best policy decision for our land. Finally the fruits of labor are the people the Knowledge Tree produces. American Bon, American Made, and American Visitors may be good or bad apples which is imperative to clearly create boundaries so as to not ignorantly group people together when the boundaries of the law of the land applies to them differently.


This is a comprehensive approach to orientation by properly sustaining long term civic education by emphasizing kinetic energy that is ever moving between each agent of change. You will work one-on-one with members of your KCE team to develop as an exceptional leader in Civic Education. You will be able to organize your life, learn about trauma, policies, and academic research to support claims about the new direction 2024 will shape up for you!

The KCE Queens Orientation Program is designed to ensure civilians you are not alone.

The Orientation Program was developed as a fourteen month long journey to decipher the issues of the city when artificial intelligence was released to the public, the Ukrainian War was at an apex entering the winter season, and the migrant crisis was rampant where city officials were making inhumane promises when the current state does not have proper management to successfully provide guidance to thousands of new arrivals. We have collaborated with academics, elected officials, teachers, community members to be able to create a powerful sustainable tool for the Sixth Congressional District. Most participants will have a different perspective of their reality once they are able to comprehend the actual mechanics at play in the government.

### How do I get started?

Each participant will complete a fifteen minute initial call with KCE. This call is to allow you to understand the aims of the program, what you truly need to create long term and short term plans to be able to achieve, and lay out that specific 2024 timeline. Once you have completed the call then we will invite you to the program. Upon receiving your program fee, you will begin your individualized journey or you may join a class with peers. Your KCE specialist will work with you to map out your desired timeline for this arduous civic journey.

  - The John Lewis Every Child Deserves a Family Act (ECDFA) would prohibit any child welfare agency receiving federal financial assistance from discriminating against any potential foster or adoptive family on the basis of religion, sex, sexual orientation, gender identity, or marital status. In addition, ECDFA would prevent discrimination against any foster youth because of their sexual orientation or gender identity.
- During the program, each author will work with the KCE team designed to support and develop your critical thinking skills to be able to direct your efforts on completing a goal in 2024.
- A Customized Timeline
  - There are diagrams, readings, conversation starters that will allow participants to complete the process in ten hours.
  - Each week we will dedicate one-on-one conversation with the KCE team
  - Live community intuition sessions to learn more about the community at large
  - Weekly office hours with specialists around more in-depth development in a specific piece of the pyramid.
- At the end of the ten hours, you will be able to design your own life and position with more tools under your disposal.

### Commitment:

Example: 1 hour/week

- Tuesday Small Council
- Tuesday Action item
- Tuesday Larger council, every 24th of the month, bigger event showcases project team work to the public
- Tuesday Action item

The day of the week can be different but the idea is that

- 1. Once a month you are in community (localized)
- 2. Twice a month you are in action mode

- 3. Once a month you are in community (at large)
- 4. This will allow you to engage actively with the material (separate) from the one hour a week you engage with your individualized material. This all depends on your schedule which will be part of the initial call.

Most alumni of the program spend more than 1-3 hours a week due to the homework and level of engagement they want to have. Treat this program as a survival guide to Queens and that you have to study or be left behind. The world is changing and technology is not being regulated in a timely manner so our critical thinking skills will differentiate our value in the new machine world.

Pricing: For community groups and schools: You may decide to provide the classroom and it is a flat rate \$400 for ten weeks or you can price it for the individuals in your organization and it will be \$300 flat. Individuals can base the rate on their status. We do not ask for proof of status but we do fill out a contract to protect all parties and it will be explained in your native language or the language you feel comfortable using. American Made: Immigrants can request language advocacy and we will translate these resources with an expert so you can get the help you need. You are allowed to barter with a service that you have medium-high quality skills or pay \$40/ hour. If you are a Queens resident you get a discount which then amounts to: \$30/hour.

### How The Modern Civic Education Program Works

### **Mission Statement**

Kinetic Civic Education, an organization focused on streamlining kitchen table issues into New York's Sixth Congressional District, home to 772,000 people immersed in 800 languages, inspires grit, growth, and hope for the Sixth through primary-source advocacy. We evaluate the gaps that the legislative branch of the government is not addressing especially when the executive and judicial branch have made changes that affect the Sixth Congressional District. By setting up active campaigns and thoughtful-advocacy sectioned resources around Health, Technology, Insurance, City Services, and Education, we are able to teach people how to sustainably organize their long term plan as well as actively engage with their community. Active campaigns such as Drones and Ethics, Queens Library and access to First Amendment Rights, Artificial Intelligence in Schools, Inadequate Healthcare Coverage Accountability, and CT-NY Highway safety allow community members to engage with primary sources to provide grit, growth, and hope for the Sixth. Partnerships with larger local community organizations collaborations have allowed us to update network contact information for people to be able to advocate for themselves.

### <u>Values</u>

### 01 Giving Chai

The magnificent effort of efficient targeting messaging to correct the wrongs committed to an enclave can be seen with the Jewish lessons around "giving chai". My father always admired the Jewish culture because of the idea of a phoenix rising from the ashes with the wing strength provided by the support of the community. The Jewish culture achieves the importance of providing social capital, materials, or physical cash to leaders, organizations, and community members so that their efforts can fill the unseen gaps in each household.

Our households all have their internal secrets and customs that are not shown to the rest of civil society. Family values on what causes shame, glee, and melancholy cannot be transparent at all times in this ever changing society Post-COVID and Post-AI. We have to set roots on what we can all come to an agreement and use as an outline to set rules for all. We have to allow those discussions to occur efficiently and effectively. Gather the leaders monthly, centralized the information to the government as a council for us ALL with transparent communication.

In such a modern world, where there are robots being revered for demonstration of the extent to our human capabilities or the robots are being exposed for potential destruction of civil society, we shall meet as an assembly and apprise, both continents and governmental elected officials, of the issues that have impacted the community from an international standpoint to a domestic standpoint.

### 02

### Bond

I learned about strong bonds with my Arab community throughout my travels. Every decision we make, even the decision to throw away food, can be a moment of impact for another individual. In the Arab community, specifically in Morocco, I saw people regularly putting bread on the side of the street in places where it was safe to eat again. My host family told me: Moroccans do not waste bread because bread is a source of life. You see bread on the streets because it is an energy source for people who are vulnerable on the street. Why throw away food that is actually providing someone else energy to make their next decision?

This bread bond reminded me of my grandmother Abuelita Rosa, who died being an active worker in her business. She made fresh bread in the morning everyday until the age of 92. When my father was growing up, their family had the town restaurant, and when my grandfather passed away my grandmother adapted to her circumstances and specialized her skills in all that is pan (bread). This symbol was that you should never stop being active and if you are lucky enough to find your passion then the activity will make you stronger, you will lead a healthier life, and allow yourself to have clarity for the next big decision.

What I have seen in this particular value of the bond to the self or to the community is that you have to be a friend to others and be a friend to yourself. Find your passion and provide people with some support without knowing this stranger-neighbor. Across cultures we are using language to communicate our values and our life missions tailored to the individual self. A bond set with the dough to make something beautiful for the next person.

### 03 Knowledge

The Asian community has taught me the value of investing in your mind. In Flushing, New York, you can find hundreds of prep schools focusing on pooling their efforts to get your child into the best school so that they can be on the path to prosperity. In China, GaoKao (高考) is an intensely studied exam, sole criterion for entrance to Chinese Universities, and is taken by Chinese students in their final year of high school; students are taught at a very young age the importance of this exam and emphasize how it will "determine" your career choices. To an extent, this is true. If we tell everyone that "just anyone can make it into higher institutions", we will actually create more harm in BIPOC\* communities than more good. We have to show people the time and effort that is needed and expected amongst wealthier peers and those around the world. Who are we actually competing with in the international and domestic world market? Are there topics that I need to learn at a younger age so I am not behind in my Adult Stage? Which books, journals, and newspapers are objective and which ones are subjective?

We must value the exposure to quality-google-search terms. An individual who wants to learn about finance may fall into traps where low quality to mid-quality actors will provide information and the government does not have a business or nonprofit institution to vet these resources. The Better Business Bureau: a private organization that provides the public with information on businesses and charities, handles consumer complaints about firms through their .A+ to F rating system. Local bureaus in the United States, Canada, and Mexico fall under the Council of Better Business Bureaus—a self-regulatory organization. If we expose terms, organization names, and agency titles to the public in a more deliberative way , we will allow others to become stronger advocates. People do not want to rely on slow services when maybe their investment can lead to a desired outcome. BIPOC communities are just tired of investing and then getting lower quality help than their peers, and lower quality results than they were promised/expected.

Therefore, Kinetic Civic Education is a center that allows people to dissect their life and file a timeline complaint to keep record of their self-activism, finding better quality resources in New York City and at the same time notifying KCE which resources are lacking or do not exist. Self-regulate low-income communities with high quality guidance because if these communities do not have physical cash capital, they are still breathing and have time to focus on their familial empire – their household. We rely on centralizing information on the actual capabilities of the services promised to us as American Citizens, American Long-term Residents, or American Visitors, instead of relying on religious organizations, ethnic enclaves, gender affiliations when you first enter into an active stage in life:

- [ADOLESCENT]
  - o **0-18**
  - o **18-25**
- [ADULT]
  - o **25-40**
  - o **40-65**
- [SUPER ADULT]
  - o **65-90**
  - o **90-120**

There is a better way to set a clear standard for the U.S. Sixth Congressional District of New York where 772,000 are interacting with the migrant crisis, rise of artificial intelligence, socio-economic and political tensions. We must uphold our American principles to hold the branches of government accountable for the people.

Kinetic Civic Education to keep the government in check by balancing the information to be civilian-centered and powered by our primary sources. Many agencies keep civilian information private and do not allow people to have possession of their information. To combat this, Kinetic Civic Education has created an organization that fills in the gaps when international politics stretches thin our district's services.

### **Five Active KCE Campaigns**

### 1. CT-NY Highway Safety

- a. We are creating workshops to understand advocacy from an active standpoint. If you have a vehicle, want to learn about regulations as technology advances, or if you believe you can contribute to the group. Please join.
- b. CT-15 should have a re-design because at least eight families have died on the same strip near Exit 57,58,59,60,61,62,63. The only way action is taken is when people make enough noise. Help us make this strip safer since it is a popular highway that connects New York, Connecticut, and Massachusetts.
- 2. Inadequate Health Coverage Accountability

- a. The Sixth Congressional District is home to diverse individuals from all ages and backgrounds, therefore, it is imperative that we secure a functioning centralized system to keep accountable the procedures, medication, and complaints made on behalf of the patients in Queens. We have such a decentralized network that when moments of crisis occurred, Elmhurst hospital was on national news throwing out bodies due to capacity. We shall not make national news again for the inefficiency that can easily be addressed. There has been a long history of city officials making decisions that are not addressing the high needs of the power back to the people when doctors have their hands tied to the institutions that employ them.
- b. What are your opinions about this topic? Have you felt like your medical team has made errors? Have you felt like there was a better way to track your health records? Has there been moments when you believed you had patient rights but they were not heard. Tell me your thoughts.

### 3. Artificial Intelligence and Schools

- a. We are focusing on the release of CHATGPT to schools and the parameters that have not been properly set by Congress and the Department of Education. We have let 917,000 public school students interact with artificial intelligence and new migrant children who have been exposed to different cultural norms in their home country. We must prepare all children for success and provide efficient support to school staff who have a hard time staying afloat.
- b. We will discuss privacy issues, plagiarism, critical thinking skills, conversations about post-Affirmative Action, and much more. We have been in contact with Superintendents and Education Councils but we need to engage with more.

### 4. Queens Public Library and First Amendment

a. We are actively working with the library systems and are in communication with Director Lu of the Queens Library system to create strategic ways to triage the services provided and encourage community members to see the value of 64 branches of QPL at your disposal. Attached is a document describing more information on the library and Kinetic Civic Education's efforts. Please join if you have a strong passion for education, QPL, first amendment rights, and willingness to learn.

### 5. Drones and Ethics

a. We are at the age of modern technology where we are introducing these devices to the public at alarming rates. We can discuss this as EVs, flybikes, scooters, skateboards, flying drones, all items that have capabilities to remove your

freedom by making one wrong move. We must understand the technology and our rights that extend to this item.

- b. When we are owners of a device with great capability, we must be held responsible when a consequence arises. For example, if a fourteen year old uses a drone, breaks into a home through a window, and takes a picture. What are the repercussions there and who should be held responsible and who will explain the rights to this child who may be tried as an adult. Invasion of privacy, breaking and entering, harassment, assault, and other charges may potentially label this child as a danger by just a simple mistake an adult failed to explain.
- c. Therefore, we have to actively be critically thinking about the implementation of such devices to the public when children and the super adults are the most vulnerable.

### November 24, 2023 PLEA: The CT-NY Highway Safety


**Outcomes:** We are suing the state of CT in behalf of road safety to get a civil engineers second opinion, Yale Daily News journalists, Yale EMT volunteers, as well as Yale Alumni have been notified and are collaborating on the project to lessen the death toll on a re-design issue of CT-15 near Exit 59-67.

**Background:** The next four pages will show you a letter Kimberly Cruz sent the YaleWomen nonprofit organization where women who graduated from Yale provide a professional and social space to obtain fellowship and guidance from peers. On this day, November 24, 2023

- According to data from the Connecticut Transportation Institute, there have been four fatal crashes on Route 99 since 2015. Three of those crashes happened in the same 1100-1200 block of roadway.
- "Silas Deane Highway and so many other of our roadways are just seeing people driving way too fast, not a couple miles an hour over the speed limit, but 10 to 20 miles an hour over the speed limit," Josh Morgan of the Connecticut Department of Transportation said. "We're seeing people texting and driving, watching videos while they're driving, things that are taking their focus off the roadway."
- "The data paints a pretty bleak picture on what's happening on Connecticut roadway," Morgan said. "Those are human lives that are being lost on our roadway, and really the vast majority are due to three things: speeding, distractions and impairment." <u>https://www.nbcconnecticut.com/news/local/drivers-call-for-safety-measu</u> <u>res-after-2-serious-crashes-in-12-hours-on-wethersfield-highway/3158223/</u>

Crash that killed two people at around 7 o'clock route 177 near Bristol Farmington, car crashed into a tree and the three children to the hospital. Why is Route 177 important because it intersects with Route 10 which intersects with CT 15 at Exit 61. These attached roads have a history of highway fatalities.



Hello YaleWomen,

My name is Kimberly Cruz, I am Yale Class 2022, Pierson College. I am the founder of Kinetic Civic Education, an organization focused on streamlining kitchen table issues into New York's Sixth Congressional District home to 772,000 people immersed in 800 languages. Happy Thanksgiving! I am asking my network of strong powerful women to help me in a time of need. I have advocated for the last ten years of my life on various issues but on the eve of The Game, on November 17, 2023 at 7:40 pm I survived a near fatal car crash, on CT 15 near exit 60, fifteen minutes away from Pierson. By some miracle, all three people in this crash survived but we have injuries that need to be heard so others do not experience a similar or worse fate. How can we activate our networks to help a Yalie and change Connecticut safety on the highway?

I do not have a degree in journalism, I do not have my desired JD/PHD degree yet and I do not have any governmental power at this moment, but I do hold myself to the very most ethical and practical approach on primary source gathering. I lead by example so I led as an advocate.

Tldr: "Rob flew, so please check on Rob... I am on some railing, I could have F\*\*\*\* died", please officer, I want to check on Rob, he could have gotten hurt..."

Rob was my roadside assistance person, a 23 year old white male, and Kesnel, a 33 year old Black man who hit the side of my car. There is a fourth vehicle but the police did not do their due diligence and have not followed up on tracking this vehicle who could have caused the whole crash. As seen in the pictures I am lucky to be alive and I am so very grateful to be here writing in pain while the back of my head burns, my neck and spine experiences excruciating pain, so much pain from the knee and below that I want to cut off that limb to rest from the pain. However, none of these symptoms stopped me from advocating for others while I simultaneously advocated for my own needs.

I would love to share more but I come here to emphasize: my Yale and Bronx Science mentorships prepared me for disaster. I did not know these individuals but truly I want you to know them and hear our story.

"A little empathy can go a long way".

- If anyone is interested in highway safety, there is a pattern on this highway that has not stopped the death of countless individuals who have been parked in a "safe designated areas" on this specific highway and have been killed when another car crashed into them (so far I have read about eight families in the last three years).

- 3) Any journalists who can explain the whole process of "getting the whole story"; from the eight articles I have read about the incident, they do not mention the state of my Nissan

Altima which ended getting hit from the left side, back, and pushed into the truck flatbed so the front of my car impacted the back of the tow truck head. I almost flew off the 25 feet drop solely by the impact of these vehicles. The articles focus on Rob which is fine but there were two other bodies who were also very hurt– Kesnel and my body– which were not mentioned to the same extent. Another instance of POC being erased from major events– maybe intentionally, not intentionally, or there are methods of information collecting that may be improved.

- 4) Are there people who are interested in medical advocacy and trying to analyze how to correct procedures in professional fields to take into account the totality of the circumstances, human biases, and proper documentation to prevent other accidents in the future.
- 5) Legislatively: any connections to people in CT with governmental power or other organizations that care about highway safety or other issues you may see fit. There is Vision Zero in New York City but I am not sure if there is a sister organization. Any wisdom would be much appreciated.

### Transcript of the day Final Destination saved me: The Initial Minutes

"Im gonna... quickly– fucking christ okay– yes please, Im scared, I'll step away from the vehicle, some other car was behind and he left, I did not take his vehicle number, I do not know if he is the one who hit me but there is one that is directly...and I am on a tow truck and Rob flew so please check on Rob, okay, Rob is over there and is talking to a civilian, he is on the road okay, and I am scared, I am on the railing on, I could have F\*\*\*\* died, f\*\*\*\* G\*\*\* holy shit, holy shit, please officer I want to check on Rob, he could have gotten hurt, one second I have to get away from this car, F\*\*\*, what happened,

[Shouting over to the car that hit the Nissan Altima at a right angle on the left side] Guy get out of the car Guy get out of the car Get out of the car Get out of the car

**WHY?**  $\rightarrow$  another person

Because we are smashed in, get away from it, Rob flew over there, my roadside assistance guy, he flew over, okay, I called 911.

#### He is over there, where is he at?

He flew over bro

What do you mean, aren't you happy you are alive? Did you see what happened?

### Am I happy I am alive? My little brother died in a car accident last year. Am I happy I am alive? Yeah, I am going up here because...

What is your name? What is your name?

#### Kesnel Minard.

Kesnel Minard.

### I am going up there because of a car accident event. I am going up here and my little brother died of a car accident and I am going right here.

We have to step away from these cars so we can be safe. Please step away.

### What was going on?

My name is Kimberly Cruz. My name is Kimberly Cruz. Your name is what?

#### **Kesnel Minard**

Okay, my blood type is A-, what is your blood type?

#### I don't know.

You need to know your blood type. Okay. Well I need to get away from these cars. I am scared of Rob \*\* starts crying\*\* Rob is over there.

### Yelling:

Rob, are you okay, are you bleeding? We called 911.

#### What do you mean he flew?

He fucking flew.

#### But like where was he at?








Kimberly grew up in Queens, and is ready to take a different approach to civic education during this modern age of misinformation and disinformation.

This website is to provide an independent hard working space of keeping city agencies accountable with the power of primary source collection. In a paid partnership with a local rising artist, founder of Franklin Comics, we are striving to bring unity to the races across Queens unifying ideologies that are internationally being torn apart but misunderstood locally on how this affects socioeconomic status. As a response to the Supreme Court's affirmative action ruling, we want to proceed with providing support when the gaps are not being filled. Judicially we have been stripped of racial and gendered rights; legislatively we must keep the government accountable to give them back.

### Words from the Founder Kimberly Cruz:

" I want to improve the definition of transparency between government officials and the public by exposing the inconsistencies in language, jargon, and promises with Kinetic Civic Education. For example, make sure kids in under-resourced communities get access to scientific thinking by exposing them to high quality google search terms to provide them a concept map on how they can get to their goal. The vision is to promote long term career help by focusing on creating an individualized toolkit for the Youth to carry with them for any civic battle.

I chose to be a warrior at a very young age. I saw my mother bleed after she sliced off two fingers in the kitchen in front of me twenty two years ago, with insufficient aid from our "guaranteed" health resources. However, that is not the trauma I am referring to; the injustice my family faced for decades when professionals in the medical and legal field do not have proper mechanisms to finish the job they promised under oath, and not forgetting low income populations are not well aware of their rights. My father and mother saw that their attorney was not equipped for the case against Flushing Hospital and they made their autonomous choice to find better representation but the procedural aspect of justice led to another U.S. family facing long term consequences.

This was in 2002. At this time, my mother had to face two surgeries and was pregnant with my younger brother, and this case ceased to exist in 2007 because an attorney failed to provide my parents adequate representation and did not fill in the gap in which his status, as a legal professional, should have shielded my parents from falling through the gaps of the legal system.

Alas, my father's pleas to obtain his primary, secondary, and the vast amount of evidence from this attorney, was met with an agreement that favored the professional who had a legal license to understand the civil rules of procedure. My parents did not fully understand when their new attorney called, and why the evidence was never transferred over. This is why I fight; my parents advocated for themselves, used city services to locate the right help, and the court transcripts allow you to replay history but the importance of record keeping without outside manipulation is the focus of this organization.

As a Kinetic Civic Educator, the main focus is to centralize the knowledge I gained at Bronx Science and Yale University to funnel more low-income students into higher education so they can be effective leaders of tomorrow. I am the product of the American Dream and the internship focusing efforts around all the skills I gained through my networks, failures, and exposure through casual conversations will allow them a safe space to work with another person in their Adolescence Stage entering their Adult Stage with a fresh set of eyes, grateful for the opportunity to use my mentors to pay it forward.

Since I am currently still working on this project, I will try to focus ahead of time to emphasize that low turnout in the polls is actually going against freedom of speech. I have seen how persistence results in proper determination in outcome and I have 2024 election hurdles but I believe the Sixth District will be able to plead their KCE and make a systematic change to this white supremacist model.

We focus on the 50 officials becoming available for the PLEA with other civic leaders, religious leaders, and others solely kept accountable to the Community Call: The of the Sixth. The 24 of every month, we communicate in person, in Flushing Meadows. An Adolescence Stage internship: The Flushing Meadows Beacon, Kinetic Civic Educators, will provide students a way to advocate for themselves, for their families, and for their future generation. The tips of how we can enter the Adult Stage protecting our trunk of five: City Services, Health, Insurance, Technology, and Education by figuring out the consensus amongst the generation to set the norms for their Adult Stage transfer into Rest, College/vocational school, Family, Workforce, Military or Death. Within the Adult Stage you have phases but you will be interacting into the system by these six and will use the five trunk markers to set high quality boundaries around the discussion of what else should be addressed for experts to know where we need help."

### Topics:

The Civic Education Club will provide basics on understanding your rights under:

- 1) Medical Rights;
- 2) Freedom of Speech;
- 3) City Agency Complaints;
- 4) Education Attainment;

5) Safety on the Streets (the potential rise of crime from unregulated e-bikes);

6) Energy Monopolies (the monopoly of Con-Edison in the age of electric cars and lack of regulation);

7) International relations: the war with Ukraine and conversations around NATO, the political issues in Palestine and Israel, rise in racist politicians, coups affecting minorities;

8) Nuclear Weapons;

9) Alliances with Asia: ASEAN, South China Sea, new USA, Korean, Japan alliance against North Korea and China;

10) Environmental Issues: Right to Clean Water, Climate Change, and the lack of infrastructure the country has POST-COVID, Shark attacks, micro plastics affecting animal behavior, the heat affecting coral reefs;

11) Satellite Access, Commercialization of Space, Space Exploration;

12) Challenges to Democracy: rise in arms violence in Latin America, Central America Unifying,El Violator Eres Tu Campaign on sexual violence;

13) Misinformation and Disinformation: democracy failing in African nations, the alt-right rhetoric, alt-left rhetoric, the social media space as a new society and the laws of governance;
14) Public Health Crisis: Rise in COVID cases and other bacterial infections effecting the North East;

15) Social Justice: discussing the closure of the inhumane conditions of Riker's Island but providing an efficient program on regulating the next jail-complex holdings across five boroughs that will not be overseen by the federal government and may be overlooked by the *newness* and lack of understanding of these contractual obligations to these complex.

In addition, discuss the federal rights we held on to deeply such as the right to abortion and affirmative action with the caveat of emphasizing mental health rights. All pertaining to these altered ideologies that are misunderstood across the United States of America citizen-perspective spectrum.
