






Here we can see a visual on how someone feels without them putting it into words; where are they on their life map. The high impact where they are investing social capital, phsyical energy, and stress.


### Main note (ideally using abbreviations)

### Key thoughts

The various primary sources I relied on experienced these situations in their district even though they were not soley using services from within their district. My brother's surgeon was unhygenic, kept the dentristry tools out in the open, vulnerable to cross contamination, and got upset when my brother started asking her about the sanitizing procedure before knocked him out. She got angry and left, then we got up and walked out the front door. Weeks later, we called the insurance company to make sure everything was cancelled and it turns out that she charged him for the removal of all four wisdom teeth even though he never received the service and waited four months before he was able to get them out by a different surgeon.

Predict + Challenge = Great Questions Advocacy may be achieved if you passionately focus on your life and the gaps in between life stages. Are you questioning your doctor's notes? Are they providing you medication in which they answered your questions on side effects and how it may interact with other medication you are on. If there is fraud, do you know that you have to MAIL you complaint about the doctor. Do you know about medical debt and when, how, and why people get into these types of debts? Finally, do you have a proper regiment to keep you livign for a long time. The age
